

# HOUSE RULES

## of the BC AS CR Hostel, Branišovská 31, 370 05 České Budějovice

1. The Hostel serves as lodging for employees and guests of institutes of the Biologic center Academy of Sciences of the Czech Republic (ASCR). Lodging is provided on the basis of written requests received from Academy institutes.
2. Hostellers are obliged to comply fully with these regulations. In case of their repeated violations, guests may be evicted from the Hostel.
3. Quiet will be maintained between 22:00 P.M. and 6:00 PM. Guests staying not bother with dust, smoke, fumes, odors, noise, waste, vibration, etc.. (loud music, shooting flares, firecrackers, excessive use of aromatic substances, etc..).
4. In the public areas prohibition smoking and use naked flames
5. Visiting hours in the rooms are from 8:00 A.M. to 22:00 P.M. If the hosteller is accommodated in a double room, the agreement of the roommate must be secured.
6. Guests may not re-arrange furniture or furnishings in the rooms or public areas of the Hostel without the agreement of Hostel Management, nor may they carry out repairs or modify in any way the electrical or other installations.
7. Guests may not keep animals in the Hostel.
8. Nowhere in the Hostel, and especially in the rooms, may guests use their own electrical appliances, with the exception of those serving for personal hygiene and personal computers.
9. Guests wishing to use their own television sets or radios must approve the payment of the broadcast reception fees.
10. Food may be prepared only in the kitchens located on each floor. All washing up will be done here as well, and not in the rooms. Guests are responsible for tidying up the kitchens.
11. For the convenience of guests the Hostel maintains washing machines as a part of the kitchen equipment, Laundry driers are available on request. Laundry may not be dried by draping it over the furniture.
12. Motor vehicles may be parked in the unguarded car park in front of the Hostel. Bicycles stored at the designated place on the ground floor - **a strict prohibition build them into the hallway** (emergency exit must be kept free)
13. In case of breakdowns or reconstructions, guests may be asked to move into another room and are obliged to comply forthwith.
14. Long-term accommodated hostellers are urged to insure their valuables against damage or theft.
15. Upon leaving his room the Guest is obliged to be sure that water is turned off, windows closed, lights and appliances switched off, and the door locked.
16. Upon departing from the Hostel the Guest is obliged leave the room until 10:00 am, to hand over the keys to the Academy institute or to the Hostel Management. Guests will be financially responsible for any damage resulting from failure to comply with these regulations.
17. Guests will be held responsible for any damage they may inflict on hostel property, in accordance with valid legal norms.
